

Airport Quiz Prize Draw!

Terms of Participation

1. The company of Fraport AG Frankfurt Airport Services Worldwide (in the following, "Fraport" or "Organizer"), entered in the commercial register of the Frankfurt am Main District Court under no. HRB 7042, with VAT ID no. DE114150623 and headquartered in 60547 Frankfurt am Main, Germany, is organizing the free "Airport Quiz Prize Draw" (in the following, "Advertising Promotion"), for which the general Terms of Participation are detailed below.

2. For organizing the Advertising Promotion, Fraport is using the services of Lucky Cycle SA/NV (in the following, "LuckyCycle"), a joint-stock company under Belgian law domiciled at Avenue Louise 523, 1050 Brussels that is entered in the Brussels commercial register under number 0548 756 417.

3. In accordance with Fraport's data privacy policy, participants are informed that LuckyCycle will use their required personal data for organizing and holding the Advertising Promotion.

4. By taking part in the Advertising Promotion, each participant implicitly accepts these Terms of Participation.

5. Fraport AG reserves the right to exclude participants who violate the Terms of Participation or provide untrue information about themselves. In such a case, any prizes won can be retroactively withdrawn and must be returned. All violations of these Terms of Participations, as well as any attempts to commit fraud and/or deceive, will as a rule be punished by excluding the culpable participant from the Advertising Promotion with immediate effect.

6. Only natural persons 18 years or older may participate. Employees of Fraport, employees of LuckyCycle, and persons employed by the companies involved in the Advertising Promotion, which are listed in Annexes 1 and 2 (in the following, collectively the "Advertising Promotion Entities"). Also excluded from participation in this Advertising Promotion are first- and second-degree kin of the persons mentioned in the previous paragraph, as well as persons who share accommodations with them.

7. Participation in the Prize Draw is free of charge and only possible online using a valid email address. Any additional costs incurred as a result of participating in the Prize Draw must be borne by the participants themselves. A given email address may only be used once for participating in the Advertising Promotion.

8. The Advertising Promotion takes place during the time period from 12 noon (CET) of April 1, 2019 until 11:59 p.m. (CET) of June 30, 2019.

9. Participants can take part in the Advertising Promotion via Facebook Messenger or WhatsApp by clicking the "Play & Win" button. Each participant must provide their email address, first and last names, and preferred salutation and accept the terms of the Advertising Promotion. This also includes providing their consent to receive the Frankfurt Airport Shopping Newsletter. The newsletter may be cancelled at any time.

10. The following instant prizes (coupons/vouchers) can be won:

- Coupons/vouchers with the following values for redemption at any of the retail partners listed in Annex 1:
 - €2 discount on a minimum purchase of €5 at one of the participating partners
 - €5 discount on a minimum purchase of €50 at one of the participating partners
 - €10 discount on a minimum purchase of €100 at one of the participating partners
- Restaurant coupon/voucher: a coffee or tea beverage for €1 at one of the partners listed in Annex 2.

11. This is a game with a 100% chance of winning, in which every participant receives their prize in the form of a coupon/voucher sent by email.

12. The prize is displayed in real time on the game website; the corresponding coupon/voucher is sent by email to the address indicated on the form. Only the coupons/vouchers described in detail in the game are distributed. The images used to illustrate them in the accompanying advertising are nonbinding and may not be used to justify any legal claims or entitlements. Instant wins may not be collected as cash or exchanged for or credited toward other prizes

13. All coupons/vouchers are valid up until and including December 31, 2019 and may be redeemed at Frankfurt Airport by presenting the prize notification email at the register of a participating partner.

Any complaints related to the present Advertising Promotion must be submitted within seven workdays after the date on which participation in the Advertising Promotion took place to the address of Fraport indicated in No. 16 of these Terms of Participation. Only complaints received in written form will be processed. Complaints that are received after this deadline or are not in writing will not be processed.

17. This Advertising Promotion involves the use of personal data, for which Fraport takes responsibility. In addition to purposes associated with Fraport activities that are not related to the Advertising Promotion, personal data will be used for direct advertising, managing participation in the Advertising Promotion, and providing prizes. In accordance with the EU General Data Protection Regulation (GDPR) of May 25, 2018, every participant has the right to check and correct their stored personal data and to deny permission for these to be used for direct advertising purposes. They may exercise these rights by sending a dated and signed statement to this effect together with a copy of their personal identification document to the address indicated in No. 16 of these Terms of Participation.

All participants may, at any time and without stating any reasons, withdraw permission for Fraport to send emails for direct advertising purposes by clicking on the "Unsubscribe" link that is included in every email.

18. It is assumed that all participants in the Advertising Promotion have read and accepted the attributes and constraints applicable to use of the Internet. Fraport and/or LuckyCycle therefore accept no liability under any circumstances for:

- transmissions via the Internet,
- poor performance of the Internet and/or the software used,

- the consequences of viruses, bugs, anomalies and technical deficiencies,
- and defects of the hardware or software of any kind whatsoever.

Fraport and LuckyCycle are liable for any damages resulting from injuries, loss of life or damage to health due to negligence or intent on the part of the Organizer or LuckyCycle, as well as for damages resulting from the intentional or grossly negligent violation of obligations by or malice on the part of the Organizer or LuckyCycle. The same holds for damages that are covered by the German Product Liability Act or a warranty or guarantee provided by the Organizer or LuckyCycle. Any additional liability above and beyond the preceding on the part of the Organizer or LuckyCycle is excluded. These liability provisions apply analogously to legal representatives, employees and agents of the Organizer and/or LuckyCycle.

Fraport and/or LuckyCycle are not liable for any direct or indirect losses or damages suffered as a consequence of participating in the Advertising Promotion or redeeming the coupons/vouchers, interruptions or other malfunctions, the exclusion of participants or completion of the Advertising Promotion for any reason whatsoever. This also applies to any direct and indirect losses or damages caused by defective connections to the website www.shop.frankfurt-airport.com or use of it on mobile devices and/or computers in stores and/or on electronic telecommunications systems. 20. The present provisions are subject to German law. The legal venue is, as far as permissible, Frankfurt am Main, Germany. Recourse to courts of law for resolving disputes is excluded.

21. If any provision of these terms of participation should be or become invalid or void, this will not affect the legal validity of the other provisions. In such a case, it must be replaced by another, appropriate provision that approximates the intention of the invalid provision as closely as possible

22.
